The Indiana High School Athletic Association, Inc. (IHSAA) conducts an annual tournament series in all its recognized sports (Tournament Series Events), is the owner of the rights to and the copyright holder of all still photographs and images, or the equivalent, all films, all videotapes and audiotapes and all live audio and visual broadcasts, or the equivalent, of or taken at any Tournament Series Event (IHSAA Audio & Visual Work) and is entitled to restrict the taking of and distribution and use of IHSAA Audio & Visual Works. Photographer specifically acknowledges all rights of the IHSAA to the IHSAA Audio & Visual Works.

1. **License.** IHSAA grants to Photographer a non-exclusive license to take still photographs and images at all 2011-2012 Tournament Series Event and a non-exclusive license to sell, distribute and use for commercial purposes any still photograph or image taken at any non-state level (sectional, regional and semi-state level) 2011-2012 Tournament Series Event.
2. **License Fee.** Photographer shall pay a license fee to the IHSAA of One Hundred Fifty Dollars (\$150).
3. **Terms.**
 - a. Photographer shall, upon request, and at any time, provide to the IHSAA a copy of any still photograph or image taken by Photographer; Photographer herewith grants an unrestricted license to the IHSAA to commercially use and distribute any such still photograph or image.
 - b. Photographer acknowledges receipt of the current *IHSAA Rules for Television, Radio, Cable and Internet Broadcasting*, current *IHSAA Policy for Photography, Film, Video and Audio* and the current *IHSAA Media Credential Information* (IHSAA Policies) and agrees that the conduct of the Photographer will conform to the IHSAA Policies.
 - c. Photographer shall indemnify and hold the IHSAA and its officers, directors, employees and agents, harmless from and against all claims, losses, liabilities, damages and expenses (including reasonable attorney's fees) arising out of any act or omission of Photographer or breach by the Photographer of any representation, warranty or agreement made by Photographer, and Photographer agrees that should there be a violation of this License agreement or the IHSAA Policies by Photographer, should there be an infringement of the rights of the IHSAA to the IHSAA Audio & Visual Works or should there be any appropriation of any IHSAA Audio & Visual Works by Photographer, then Photographer shall pay the IHSAA any damages from such breach, violation, infringement or appropriation, together with attorney fees and expenses incurred by the IHSAA in enforcing this License or the IHSAA Policies or in enforcing any of the IHSAA rights.
 - d. The License granted, and all benefits attendant herein, may be terminated by the IHSAA for any violation of this License agreement or any violation of the IHSAA Policies.

This license is not a credential, and does not grant admission to an event or special access to any location at a venue.
