MINUTES

The revised minutes of the February 20, 2015 meeting were recommended for approval. A motion for approval was made by Jimmie Howell; seconded by Geoff Penrod; motion passed 13-0.

APPROVAL OF INDIANA HIGH SCHOOL TENNIS COACHES ASSOCIATION PROPOSALS

Assistant Commissioner Kaufman reviewed the tennis proposals submitted last month by the Indiana High School Tennis Coaches Association.

1. During JV matches, coaching should be allowed throughout the match as long as it does not violate the 20 second limit between points or the 90 second limit at changeovers.

A motion for approval was made by Deborah Watson; seconded by Mike Broughton; motion passed 13-0.

- 2. All four IHSAA State Finals quarterfinal matches should be played at the same site. A motion for approval was made by Geoff Penrod; seconded by Deborah Watson; motion failed 0-13.
- 3. Semi-state matches should start at 12:00pm instead of 10:00am due to travel distances. A motion for approval was made by Dave Worland; seconded by Jimmie Howell; motion passed 13-0.
- 4. The IHSAA should provide State Finalist medals for all eight of the "Eight at State" team finalists. A motion for approval was made by Jim Brown; seconded by Mike Broughton; motion failed 0-13.

APPROVAL OF SWIMMING AND DIVING COACHES ASSOCIATION PROPOSALS

John Sincroft, Warren Central HS and Dana Culp, Eastern (Greentown) HS representing the IHSSCA and ICGSA, presented the following proposal:

1. At the IHSAA swimming and diving state championships, if a fifth heat is needed because of more than 32 qualifiers in an event, fill the heat with the next overall faster swimmers.

WRESTLING COACHES ASSOCIATION PROPOSALS

Tyson Skinner, Jeffersonville High School and Danny Struck, Madison Consolidated High School presented the following proposals:

- 1. Change team scoring to begin in the first round of three levels of the state tournament regional, semi-state, and state finals.
- 2. Add wrestle backs at the regional and semi-state levels.
- 3. Allow for teams selected for the IWSWCA Team Stet Duals to have one extra weigh-in.
- 4. Allow for the 28 man sectional entry roster to allow kids to be put in at their lowest qualifying weight, but to move up multiple weight classes if needed.
- 5. All for an exemption of one tournament or wrestling meet outside of the 300 mile competition rule.

IHSAA C EUGENE CATO SCHOLARSHIP RECIPIENTS

Commissioner Cox reported on the Brady Awards Banquet to be held at the Indiana Roof Ballroom on April 16, 2015, in conjunction with the Methodist Sports Medicine awards ceremony. Scholarship recipients and their parents will be guests of the IHSAA at this event.

Haley Harrell of Plymouth High School has excelled not only in athletics, but also academically. She is ranked fifth in her class of 280 with a 4.3 GPA. As a three-sport athlete, Haley has earned 11 letters and numerous honors and awards.

She has held multiple leadership positions on and off the court, serving as both class president and varsity volleyball captain all four years; she was also named varsity basketball captain during her sophomore, junior, and senior seasons as well. Furthermore, Haley is an active member of the Fraternal Order of Police #195, which organizes "Shop with a Cop" during the Christmas season and "Pack-A-Backpack" for kids to receive school supplies. She is the daughter of Julie Harrell.

Fort Wayne Canterbury's **Christian Kreiger** has excelled beyond the playing field during his tenure in school. While serving as team captain for both the golf and basketball teams, Christian is also a member of the IHSAA's Student Advisory Committee and will be graduating this year with a 4.25 GPA. As the chairman of Canterbury's Service Committee, he regularly volunteers in the community; he has helped orchestrate service projects that include working at Fort Wayne's Mustard Seed Furniture Bank and Canterbury's "Blessings in a Backpack" program. While at Warsaw, Jake earned six varsity letters while participating on the football and basketball teams. He was a captain in both sports and was selected as an Indiana Academic All-star in football. Jake is also a member of the National Honors Society, is the president of the KEYS club, and helped create the Warsaw community fundraiser of "Hoops for Homework", which raises funds for the Baker Youth Club. Lauren not only shines in the classroom and as an athlete, she also serves as the Student Council President and the National Honor Society Vice President. Perry Central's **Grace James** will graduate at the top of her class of 79 with a 4.0 GPA. Outside of the classroom, Grace was a three-sport athlete and earned varsity letters in volleyball, track, and basketball. She captained the volleyball team to a regional championship in 2014 and holds school records for most aces and most assists in a single season. Grace has served as the Vice President for multiple organizations including the National Honor Society, Student Council,

Student Wellness Awareness Team and Key Club. As a member of those organizations, she has contributed hours of community service and helped raise funds for numerous charities. She is the daughter of Raymond James.

Norwell's **Monica Frauhiger** will graduate as her class' valedictorian with a perfect GPA of 4.0. She has excelled not only academically, but also athletically, earning seven varsity letters in cross country and track and field while also participating in basketball and tennis during her four-year career. She was a member of the cross country sectional team champions her freshman and sophomore years and was voted team captain her senior year. Monica is the Vice President of the National Honor Society and has held multiple leadership roles within the Student Council. She was named captain of the cross country team for three years and has won multiple honors and awards for both sports. SPORTSMANSHIP

Assistant Commissioner Walter reported that the Association has received 664 unsporting behavior reports which include 106 student/coach ejections for the winter season. We will reconvene the IHSAA Sportsmanship Task Force to study and clarify expectations and penalties.

FINANCIAL REPORTS

- 1. Assistant Commissioner Searcy presented a financial report for the girls and boys swimming & diving tournament series'. Overall, the girls tournament showed an increase in total attendance and net revenue, but the boys tournament reflected an overall decrease in attendance and net revenue.
- 2. Assistant Commissioner Faulkens reported on the financial status of the wrestling tournament series. Attendance during the tournament series was higher than the previous year. In addition, the IHSAA net increased slightly from last year's figures.
- 3. Commissioner Cox submitted the 2014-15 Budget Analysis by Sport.

LITIGATION

Attorney Robert Baker updated the Executive Committee on the current status of pending litigation against the Association.

PENALTIES ASSESSED

The following penalties were assessed for various violations of the IHSAA By-Laws:

Fort Wayne Bishop Dwenger High School - Commissioner Cox reported the following action as a result of a violation of Rule 15-2.2c (Assistant softball coach provided instruction to a player during the school year out of season).

- 1. The Fort Wayne Bishop Dwenger High School softball program is issued a warning.
- 2. Assistant Coach Jeannie Mellish is reprimanded for this violation.

Gary Roosevelt High School - Commissioner Cox reported the following action as a result of a violation of Rules 3-6 (*Fight in stands during boys' basketball game caused suspension of contest*).

- 1. The Gary Roosevelt boys' basketball program is issued a warning.
- 2. Gary Roosevelt shall not host any additional boys' basketball contests in their facility for the remainder of the 2014-15 season. Should the contest with Fort Wayne Bishop Luers be rescheduled, it must be at the opponents' venue or a neutral site.
- 3. The Gary Roosevelt administration is instructed to review existing safety and security plans established by the school corporation and provide a written plan of enhancements to the policy to insure the safety of all attendees and participants. This written plan is due to the offices of the IHSAA by March 31, 2015.
- 4. It is noted that the players, coaches and staffs of both schools were not involved in these altercations in any manner. The IHSAA contest officials are commended for their actions in the removal of the teams from the gymnasium.

Lapel High School - Commissioner Cox reported the following action as a result of a violation of Rules 3-10 (Girls' track athlete participated in a meet without a pre-participation physical examination and consent form on file).

- 1. The Lapel High School girls' track and field program is issued a warning.
- 2. Coach Krista Loller is reprimanded for allowing this violation to occur. This is a health and safety issue and it is absolutely imperative that the "IHSAA Pre-Participation Evaluation Form" complete in every detail be on file for all student athletes prior to their participation in a practice, let alone an interscholastic competition.
- 3. The student athlete shall be declared ineligible until this requirement is met.

Penn High School - Commissioner Cox reported the following action as a result of a violation of Rules 15-1.1.1d (*Wrestler participated in practice with an athlete not belonging to the school*).

- 1. The Penn High School wrestling program is issued a warning.
- 2. Coach Brad Harper is reprimanded for allowing this violation to occur.
