Per Rule 1-4 of the IHSAA By-Laws, sports that do not maintain at least 25% participation of the member schools will be reviewed annually for purposes of determining future tournament and recognition status. A motion to continue IHSAA sponsorship of girls' gymnastics was made by Steve Cox; seconded by Jimmie Howell; motion passed 17-0.

Assistant Commissioner Walter reported that the 2016 Gymnastics State Championships cannot be held at Ball State University on the original scheduled date. The consensus of surveyed schools indicated that the tournament series should be started one week earlier, in order to secure the Ball State University venue.

A motion to start the IHSAA Girls Gymnastics Tournament Series on February 27, 2016, one week earlier, was made by Dave Worland; Mike Broughton; motion approved 17-0.

APPROVAL OF SWIMMING AND DIVING COACHES ASSOCIATION PROPOSALS

Assistant Commissioner Searcy reviewed the proposals presented by the Indiana Coaches of Girls Sports Association and the Indiana High School Swim Coaches Association during the March Executive Committee meeting.

1. At the IHSAA swimming and diving state championships, if a fifth heat is needed because of more than 32 qualifiers in an event, fill the heat with the next overall faster swimmers.

A motion to approve the proposal was made by Richard Lance; seconded by Mike Whitten; motion failed 0-17.

APPROVAL OF WRESTLING COACHES ASSOCIATION PROPOSALS

Assistant Commissioner Faulkens reviewed the proposals presented by the Indiana High School Wrestling Coaches Association during the March Executive Committee meeting.

1. Change team scoring to begin in the first round of three levels of the state tournament – regional, semi-state, and state finals.

A motion to approve the proposal was made by Paul Neidig; seconded by Steve Cox; motion approved 17-0.

2. Add wrestle backs at the regional and semi-state levels.

A motion to approve this proposal was made by Richard Lance; seconded by Patti McCormack; motion failed 1-16, with Debb Stevens voting in favor.

3. Allow for teams selected for the IHSWCA Team State Duals to have one extra weigh-in.

A motion to approve this proposal was made by Dave Worland; seconded by Don Gandy; motion failed 0-17.

4. Allow for the 28 man sectional entry roster to permit student athletes to be put in at their lowest qualifying weight, but to move up multiple weight classes if needed.

A motion to approve this proposal was made by Richard Lance; seconded by Jimmie Howell; motion failed 0-17.

5. Allow for an exemption of one tournament or wrestling meet outside of the 300 mile competition rule.

A motion to approve this proposal was made by Mike Broughton; seconded by Richard Lance; motion failed 0-17.

SPORTSMANSHIP

Assistant Commissioner Walter relayed information pertaining to unsportsmanlike conduct reports that have been received this spring. Unsportsmanlike conduct reports for sports have decreased from last year's figure. Assistant Commissioner Walter also reported on those member schools that fall below an acceptable sportsmanship score. Final scores will be tabulated at the end of the spring season. The Sportsmanship Task Force will be meeting on May 11, 2015, to analyze recommendations that were established the previous year.

FINANCIAL REPORTS ON SELECTED WINTER SPORTS

Assistant Commissioner Gardner reported on the attendance and finances for the 2014-15 Boys Basketball Tournament Series. Total paid attendance decreased approximately 6% from last year. While expenditures decreased as well, the net result reflected an 8% decrease in the tournament net.

Assistant Commissioner Walter reported that attendance for the 2014-15 Girls Basketball Tournament increased, particularly at the state level. Expenditures increased as well, however, which reflected a 24.5% decrease in the net.

Assistant Commissioner Walter provided the Executive Committee with the annual attendance and financial report for the 2014-15 Gymnastics Tournament Series. The net balance for the gymnastics tournament series showed a deficit of approximately \$5,300, which is a slight decrease in net over the previous year.

Commissioner Cox presented the budget analysis by sport through the Winter season.

LITIGATION REPORT

Attorney Robert Baker updated the Executive Committee on the current status of pending litigation against the Association.

REPORT OF NFHS SUMMIT AND LEGAL MEETING

Commissioner Cox and Attorney Bob Baker attended the two day event in which a variety of legal issues were shared amongst state associations executive directors and association attorneys.

PENALTIES ASSESSED

The following penalties were assessed for various violations of the IHSAA By-Laws:

Attica High School - Commissioner Cox reported the following action as a result of a violation of Rule 9-13 (Softball coach conducted a practice on Sunday).

- 1. The Attica High School softball program is issued a warning. This warning is official notice that an illegal act has occurred, is a matter of record, and shall not be repeated.
- 2. Coach Dean Branstetter is reprimanded for allowing this violation to occur.
- 3. The IHSAA accepts the measures taken by the school administration in this matter as appropriate disciplinary actions.

Eastbrook High School - Commissioner Cox reported the following action as a result of a violation of Rule 18-1 (Softball player participated in a contest while academically ineligible).

- 1. The Eastbrook High School softball program is issued a warning.
- 2. The student involved in this violation is declared ineligible until such time the student may become academically eligible.
- 3. The interscholastic contest in which this ineligible athlete participated in shall be forfeited if Eastbrook was victorious. The opposing school shall be made aware of this violation.

Goshen High School - Commissioner Cox reported the following action as a result of a violation of Rule 9-13 (Girls' tennis coach conducted a practice on Sunday).

- 1. The Goshen High School girls' tennis program is issued a warning.
- 2. Coach Austin Louks is reprimanded for allowing this violation to occur.

Goshen High School - Commissioner Cox reported the following action as a result of a violation of Rule 18-1 (Two boys' track athletes participated in a meet while academically ineligible).

- 1. The Goshen High School boys' track and field program is issued a warning.
- 2. The students involved in this violation are declared ineligible until such time the students may become academically eligible.
- 3. The interscholastic contest in which the ineligible athletes participated shall be rescored after removing the scores of the ineligible athletes. The opposing schools shall be made aware of this violation.

Hagerstown High School - Commissioner Cox reported the following action as a result of a violation of Rule 9-13 (Coaching staff conducted a middle school clinic with high school golfers instructing and participating on Sunday).

- 1. The Hagerstown High School boys' golf program is issued a warning.
- 2. Coach Bill Mullin is reprimanded for allowing this violation to occur.

Indiana School for the Deaf - Commissioner Cox reported the following action as a result of a violation of Rule 4-1 (A student that will turn 20 years of age before the state championship has participated in multiple softball games).

- 1. The Indiana School for the Deaf softball program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition.

3. In accordance with Rule 3-9 of the IHSAA By-Laws, Indiana School for the Deaf shall notify all opponents of this violation and any contests where the Indiana School for the Deaf was victorious shall be forfeited.

Michigan City High School - Commissioner Cox reported the following action as a result of a violation of Rule 14-1 (JV baseball team participated in a two inning contest without licensed officials).

- 1. The Michigan City High School baseball program is issued a warning.
- 2. This illegal contest shall stand as one contest toward the maximum number of contests allowable for the team to play during the regular season.

New Prairie High School - Commissioner Cox reported the following action as a result of a violation of Rule 14-1 (JV baseball team participated in a two inning contest without licensed officials).

- 1. The New Prairie High School baseball program is issued a warning.
- 2. This illegal contest shall stand as one contest toward the maximum number of contests allowable for the team to play during the regular season.

Winamac High School -Commissioner Cox reported the following action as a result of a violation of Rule 19-3 ((Boys' track athlete participated in a meet without an approved transfer report on file).

- 1. The Winamac High School boys' track and field program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible until an approved transfer report is on file.
- 3. The contests in which the ineligible athlete participated in shall be rescored after removing the ineligible athlete's scores and the opposing schools shall be notified of this violation.
