APPROVAL FOR EXECUTIVE STAFF AND BOARD MEMBERS TO ATTEND 95th NFHS SUMMER CONFERENCE

Commissioner Cox requested permission for the executive staff and the Board of Directors to attend the annual meeting of the National Federation of State High School Associations, June 28 – July 2, 2014. A motion to approve this request was made by Tim Grove; seconded by Jimmie Howell; motion passed 16-0.

FOOTBALL COACHES PROPOSALS

Jason Simmons, Darrin Fisher, Kurt Tippmann and Bob Gaddis (Indian Football Coaches Association) presented the following the proposals -

1. Addendum to 15-3.1 to read: For football there shall be no full contact and protective equipment is limited to helmet, shoes, shoulder pads, girdles, and mouthpieces for a maximum of 12 days to be submitted to the member school's athletic director or building principal. Football Activity Days can consist of one workout not to exceed 2 hours in length.
2. Addendum to 15-3.1f to read: For football camps or inter-school competition days there shall be no full contact and protective equipment is limited to helmet, shoes, shoulder pads, girdles and mouthpieces for a maximum of 5 days to be submitted to the member school's athletic director or building principal.

3. Change 54-4 to read: All organized football practices by players or teams shall be limited to the period beginning Monday of IHSAA calendar week 5 and terminating on the date the team is eliminated. The first day should have no full contact and protective equipment is limited to helmets, shoes, girdles and mouthpieces. If multiple practices are held, the total time on the field must not exceed 3 hours. If one practice only, the total time on the field must not exceed 2 ½ hours. Day 2 and Day 3 should have no full contact and protective equipment is limited to helmets, shoulder pads, shoes, girdles and mouthpieces. If multiple practices are held, the total time on the field must not exceed 3 hours. If one practice only, the total time on the field must not exceed 2 ½ hours. Full pads and full contact practices may begin on Day 4. Beginning with Day 4, if multiple practices are held in a day the total time must not to exceed 5 hours. If one practice only the total time on the field cannot exceed 3 hours. The listed guidelines should be followed starting with Monday of the IHSAA calendar week 5: no back to back calendar days of double practices, only one full contact practice per day allowed on a daily double practices are held, a practice day with 3 sessions will not be held, the break between practices must be 3 hours in duration with no physical exertion permitted – classroom instruction, not to exceed 45 minutes, is permitted during the break, an indoor walkthrough in a climate controlled walkthrough practices are permitted on a single practice day following (or prior to) the mandatory 3 hour break lasting no more than 45 minutes with no protective equipment worn.

PENALTIES ASSESSED

The following penalties were assessed for various violations of the IHSAA By-Laws:

Alexandria Monroe High School - Commissioner Cox reported the following action as a result of a violation of Rule 18-1 (*Wrestler participated in a match while academically ineligible*).

1. The Alexandria Monroe High School wrestling program is issued a warning.
2. The interscholastic contest in which the ineligible athlete participated shall be rescored after removing the scores of the ineligible athlete. The opposing school shall be made aware of this violation.

Bloomington South High School - Commissioner Cox reported the following action as a result of a violation of Rule 9-13 (*Volleyball coach made recruiting films of players on a Sunday*).

1. The Bloomington High School South volleyball program is issued a warning.
2. Coach Eugene Kim is reprimanded for this violation. Ignorance of the rules is not an acceptable reason for a rules violation.
3. The IHSAA accepts and supports the corrective actions of Bloomington High School South as appropriate measures in this matter.

Bowman Leadership Academy - Commissioner Cox reported the following action as a result of a violation of Rule 10-1 (*Boys' basketball team participated in a contest against a team with an address outside the mileage limitation*).

1. The Bowman Leadership Academy boys' basketball program is issued a warning.
2. Due to the fact that the Bowman Academy participated in an event which ultimately violated IHSAA by-laws, the 2014-15 Bowman Academy boys' basketball schedule shall not exceed a total of 19 interscholastic contests. A confirmed boys' basketball schedule for the 2014-15 season shall be provided to the Association prior to the beginning of the 2014-15 season.
3. The administration of Bowman Leadership Academy is strongly urged to insure compliance with IHSAA by-laws regardless of unique circumstances the school may encounter.

Brown County High School - Commissioner Cox reported the following action as a result of a violation of Rule 60-6 (*Wrestler participated in violation of the provisions of the weight management program*).

1. The Brown County High School wrestling program is issued a warning.
2. Head Coach Mark Bruner is reprimanded for committing this violation. Ignorance of the provisions of the weight management program is not an acceptable excuse for a rules violation.

Brownsburg High School - Commissioner Cox reported the following action as a result of a violation of Rule 8-2 (*Boys' diving coach held unethical conversations with official about the scoring of dives during an interscholastic competition*).

1. The Brownsburg High School boys' swimming and diving program is issued a warning.
2. Head Coach Josh Saylor and Diving Coach Diana Winder are severely reprimanded for these actions. The integrity of the competition specifically and the sport of diving in general was compromised in this situation and has no place in education based athletics.

Chesterton High School - Commissioner Cox reported the following action as a result of a violation of Rule 15-1.1a (*Boys' swimmer participated in a non-school sponsored event without an approved waiver*).

1. The Chesterton High School boys' swimming and diving program is issued a warning.
2. The student shall be suspended for next boys' swimming and diving meet on the current Chesterton High School schedule.

Fort Wayne Bishop Dwenger – Commissioner Cox reported the following action as a result of a violation of Rule 19-3 (*Foreign exchange student participated in multiple gymnastics meets without an approved foreign exchange report on file*).

1. The Fort Wayne Bishop Dwenger High School girls' gymnastics program is issued a warning.
2. The student athlete involved in this violation shall be suspended and declared ineligible an approved foreign exchange student eligibility report is on file.
3. The contests in which the ineligible athlete participated in shall be rescored after removing the ineligible athlete's scores and the opposing schools shall be notified of this violation.

Huntington North High School - Commissioner Cox reported the following action as a result of a violation of Rule 15-1.2a (*Boys' basketball player participated in multiple non-school sponsored games during the authorized contest season*).

1. The Huntington North High School boys' basketball program is issued a warning.
2. The student athlete involved in this violation shall be suspended for the next three games on the Huntington North High School regular season schedule.

Indianapolis Lutheran High School - Commissioner Cox reported the following action as a result of a violation of Rule 52-3c (*Boys' basketball player participated in more than five quarters in a single session*).

1. The Indianapolis Lutheran High School boys' basketball program is issued a warning.
2. All six quarters shall count against the maximum number of quarters allowed for the student athlete involved in this violation.
3. In accordance with Rule 3-9, Lapel High School shall be notified of this violation and if Indianapolis Lutheran was victorious, the varsity game shall be forfeited.

LaVille High School - Commissioner Cox reported the following action as a result of a violation of Rule 15-2.2d (*Softball coach instructed a freshman student in a non-school sponsored practice*).

1. The LaVille High School softball program is issued a warning.
2. Head Coach Scot Shearer is reprimanded for committing this violation. Ignorance of the rules or not confirming the grade level of participants in a non-school program is not an acceptable excuse for a rules violation.

Lawrence Central High School - Commissioner Cox reported the following action as a result of a violation of Rule 20-1 (*Members of football coaching staff met with parent and student prior to enrollment at new school and before the cessation of attendance at former school - PROBATION*).

1. The Lawrence Central High School football program is placed on probation for the 2014-15 season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
2. Coaches Jed Richman, Steve Tutsie and Cory Clark are reprimanded for allowing this unacceptable violation to occur. Ignorance of the rules is not a valid reason for a rules violation.
3. Coaches Jed Richman, Steve Tutsie and Cory Clark shall be suspended one regular season contest within the first three scheduled contests exclusive of the approved controlled scrimmage during the 2014-15 season. At the discretion of the school administration, these suspensions may be served as a group in one contest or spread across the first three contests.
4. Lawrence Central High School shall continue its ongoing efforts of education with the football coaching staff of the IHSAA by-laws, specifically to Rules 19 and 20.
5. Athletic Director Jeff Irwin is commended for his thorough investigation and written findings of this matter.

Northview High School - Commissioner Cox reported the following action as a result of a violation of Rule 15-1.2a (*Boys' basketball player participated in a non-school sponsored game during the authorized contest season*).

1. The Northview High School boys' basketball program is issued a warning.
2. The student athlete involved in this violation shall be suspended for the next two games on the Northview High School regular season schedule.

Speedway High School - Commissioner Cox reported the following action as a result of a violation of Rule 18-1 (*Wrestler participated in multiple meets while academically ineligible*).

1. The Speedway High School wrestling program is issued a warning.
3. The interscholastic contests in which the ineligible athlete participated shall be rescored after removing the scores of the ineligible athlete. The opposing schools shall be made aware of this violation.

Tippecanoe Valley High School - Commissioner Cox reported the following action as a result of a violation of Rule 19-3 (*Foreign exchange student participated in multiple girls' swimming meets without an approved foreign exchange report on file*).

1. The Tippecanoe Valley High School girls' swimming and diving program is issued a warning.
2. The student athlete involved in this violation shall be suspended and declared ineligible an approved foreign exchange student eligibility report is on file.
3. The contests in which the ineligible athlete participated in shall be rescored after removing the ineligible athlete's scores and the opposing schools shall be notified of this violation.

Tri-West Hendricks High School - Commissioner Cox reported the following action as a result of a violation of Rule 18-1 (*Boys' swimmer participated in multiple meets while academically ineligible*).

1. The Tri-West Hendricks High School boys' swimming program is issued a warning.
2. The interscholastic contests in which the ineligible athlete participated shall be rescored after removing the scores of the ineligible athlete. The opposing schools shall be made aware of this violation.

Zionsville High School - Commissioner Cox reported the following action as a result of a violation of Rule 5-2 (*Volleyball coach awarded cash prize to student with fewest serving errors over the season*).

1. The Zionsville High School volleyball program is issued a warning.
2. Zionsville student athlete Cyra Bammer shall return the amount of money provided to the athletic director. The school may return the funds to the student athletes making the contributions, use the funds within the athletic department or donate the funds to a charity of the school's choice.
3. Coach Dawn Jones is reprimanded for this violation. Ignorance of the rules is not an acceptable excuse for a rules violation.
