




#### Response Counts

### **D. Consideration for Approval – Unified Track & Field Maximum Effort Rule**

On behalf of the Unified Coaches Association of Indiana, Assistant Commissioner Brian Lewis and Director of Champions Together Brian Avery spoke to the four proposals below including potential adjustments to the Maximum Effort rule as well as a clarification regarding a student's ability to participate in traditional and Unified Track and Field in the same year.

#### **Motion:**

Motion moved by Brian Strong and motion seconded by Chad Gilbert. Approved 19-0.

1. If a competitor exceeds his/her maximum effort in a field event, that performance is considered a scratch. Three scratches would constitute zero points for said student in that event. Should the same competitor have a performance that falls under his/her maximum effort limits, that effort should be counted.
2. The Maximum Effort standard in Field Events would be changed to the following percentages of the highest seed per flight. 30% in lowest performing flight, 25% in the next lowest flight and 20% in all remaining flights.
3. The Maximum Effort rule in running events will not be changed at this time as the committee feels most tournament level issues have arisen in Field Events.
4. This is a clarification of an existing rule. A student may participate in Traditional and Unified Track & Field in the same season, but may appear on only one Tournament roster. ALL Unified T & F participants MUST have their TWO performance entries be from Unified Track & Field meets. The committee feels the intent of this rule is to assist small schools or those who may be lacking enough partners to field complete teams.

## **II. REPORTS**

### **A. Athletic Directors Survey Data**

Eric Murray and Robby Kimes of 360 Group presented the results and data of an athletic directors survey they initiated in October of 2025.

The results of the survey will be shared with the membership in the coming days via IHSAA.org.

### **B. 2026-28 School Classifications and Tournament Realignment**

The Indiana Department of Education just released enrollment figures in recent days which will be used for the next two years of classifications (2026-27, 2027-28) in the various team sports.

Some adjustments will need to be made in consultation with some schools and Commissioner Paul Neidig anticipates those final enrollments to be shared with the membership only in the next two weeks with a public release that includes new classifications to follow at a later date.

The realignment committee will meet on Thursday, March 5 to place schools in their respective sectionals in the three, four and six class sports. Those recommendations will then be presented the Executive Committee for a vote at its May 5 meeting.

### **D. Softball Coaches Proposals**

Kate Todd, Executive Director of the Softball Coaches Association of Indiana, presented the following rules proposals.

No action was taken but will be considered and voted upon at a later Executive Committee meeting.

#### **Proposal #1: change the IHSAA By-Law to add the language below as Rule 107-3e.**

e. If a school schedules a Varsity and JV softball contest in the same session, meaning same school and on the same day, Varsity to be concluded prior to the JV contest, five

players from the Varsity contest may participate in the JV contest. The JV roster cannot exceed 11 players in that contest on that date. No more than 12 innings can be played by one player.

### **Proposal #2: require the use of the double bag at first base.**

Explanation: A double bag is an orange base that is connected to the standard white bag at first base. The first baseman uses the white bag inside the foul line and the baserunner uses the orange bag outside the foul line to minimize collisions. If runners are taking extra bases on a hit, they use the inside base. The double bag gives the runners a base to run through that keeps them in their running lane without having to move back into fair territory to touch the regular white bag.

### **Proposal #3: change the IHSAA By-Law to add the bold language.**

#### Controlled Scrimmage

##### Format

This scrimmage shall consist of **up to** four innings. Each team will send ten batters to the plate in each half inning regardless of the number of outs that have been made. This allows for each defensive player plus a designated hitter to bat each inning. As in any game, the batting order shall be established by the coach. A scoreboard may only be used to show balls and strikes; no team score shall be kept.

During each inning the team at bat should attempt to create as much offense as possible and the defensive team shall attempt to retire all ten hitters. No pitcher may pitch to more than fifteen batters during the entire scrimmage. It is recommended that any player entering the scrimmage be allowed to play one complete inning.

In order for this scrimmage to be a worthwhile event, benefiting both teams, every effort should be made to utilize pitchers who have the ability to throw strikes. Walks do not serve the needs of either squad. Since no score is being kept and the goal is for this to be a winning experience for both teams, coaches should emphasize to their pitchers the importance of throwing strikes.

Coaches Option for Softball: By mutual agreement of the two head coaches, **any** inning could be a situation inning whereby:

1. Every batter would start with a count of 1 ball and 1 strike. This would minimize the number of pitches for a pitcher and maximize the importance of throwing strikes.
2. There would be two runners placed on base by the offensive coach to work on base running situations; bunting situations; etc. If someone scores or makes an out on the bases, the coach could replace the base runner so that each hitter in this inning would be batting with two runners on base. The coaches should confide in each other what they are attempting to accomplish.

At least two batters shall attempt to bunt (even with two strikes) during each half inning. These must be two different individuals each inning; the same individuals may not be the designated bunters for their team throughout the scrimmage. When it is apparent a batter is attempting to bunt, the pitcher should make every effort to

throw the ball over the plate rather than attempting to see how many players she can strike out. The purpose is to provide an opportunity for the offensive team to practice bunting and advancing runner/s while the defensive team hones their skills in defending the bunt.

#### **E. Baseball Coaches Proposals**

Justin Keever of Noblesville, Ryan Berryman of Western, Erik Hisner of Eastern (Greentown), and Shane Edwards of Oak Hill, all representing the Indiana High School Baseball Coaches Association, presented the following rules proposals.

No action was taken but will be considered and voted upon at a later Executive Committee meeting.

**Proposal #1:** the official starting date for baseball practice will be changed from M – Wk37 to M – Wk36 of the IHSAA calendar and the first official baseball contest date will be changed from M – Wk39 to M – Wk38.

**Proposal #2:** (this proposal is being submitted in conjunction with softball) change the IHSAA By-Laws to add the language below as Rule 51-3e and 51-3f.

- e. A varsity player may exceed the game limit if he is participating on a sub-varsity level team for the purpose of that sub-varsity level team having a full roster for competition. No player shall exercise this option more than 4 times during a contest season and it will not count towards the maximum number of varsity games played. A program can only use this option to achieve a maximum sub-varsity roster of 11 players for a specific contest; additionally, it will only be designated / recorded after the current maximum number of season baseball games has been met.
- f. The player using this designation cannot be the same player noted in 51-3d.

**Proposal #3:** Change the baseball state tournament format to double the number of sectionals and have a maximum number of four teams per sectional.

**Proposal #4:** Change the baseball state tournament format to double the number of sectionals and have a maximum number of four teams per sectional. All three and four team sectionals will be seeded (based on MaxPreps).



### **Student-Athlete Transfer Report**





**L. Officials**

Assistant Commissioner Brian Lewis provided the current list of licensed officials by sport and results from the Officials' Host School Contest Survey.

The officials' registration fee was discussed, with a proposal to increase it starting April 1st, though this was not finalized.

The group also addressed changes to official uniforms, removing professional and certified designations, and discussed a new policy limiting annual assigner fees.

**M. Sportsmanship**

Assistant Commissioner Jane Schott shared a list of exemplary sporting reports for the period of Nov. 3 to Jan. 9 which includes an overlap with fall and winter sports.

She also shared a list of unsporting reports which also included several spectator ejections from contests.

**N. Track & Field, Tennis Results Update**

Assistant Commissioner Jane Schott reported that MileSplit will become the new track and field reporting service for member schools this spring. Schools should incur minimal changes from what they've been doing in previous years during tournament time.

Assistant Commissioner Chris Kaufman met with the United States Tennis Association recently. He said the IHSAA will begin using a USTA-backed free platform called Serve Tennis and our tennis coaches will be required to input their player's results throughout the season to help with transparency. This will be rolled out to tennis coaches throughout the state in the coming weeks.

**O. Technology**

Director of Information Technology Luke Morehead is adding a section for emergency contacts to every licensed official's account.

He also demonstrated some design improvements to myIHSAA.net.

**P. Legal**

General Counsel Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association and recent Case Review Panel rulings.

**Q. Legislative**

Commissioner Paul Neidig provided an update to SB 199 which could change the makeup of the Case Review Panel. Related to HB 1004, Williams-Briles relayed that the AED language that was inserted into statute last year has been completely struck mainly due to practicality and deregulation toward a more local responsibility.

**R. Penalties Assessed**

*Anderson Preparatory Academy - Girls Basketball - Rule 18-1 (A student-athlete participated in multiple contests while academically ineligible)*

- The Anderson Preparatory Academy High School Girls basketball program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until they meet the minimum academic standards for eligibility.
- In accordance with Rule 3-9, the contests in which the ineligible student-athlete participated in shall be forfeited and the opposing schools shall be notified of this violation.
- The administration of Anderson Preparatory Academy High School is recognized for its appropriate management of this member school bylaw infraction. It is an essential responsibility of each member school to adhere to the association's bylaws and to promptly self-report any violations to the Commissioner, as stated in Rule 3.

*East Noble - Boys Basketball - Rule 15-3 (An Assistant Coach coached student-athletes in an AAU setting during the member school's designated moratorium week)*

- The East Noble High School boys basketball program has been issued a warning for allowing this member school bylaw violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Further digressions relate to Member school bylaws by student-athletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of East Noble High School is commended for its handling of this member school bylaw violation. Part of an IHSAA member school's duty is to uphold the member school bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

*Northview - Girls Wrestling - Rule 18-1 (A girls wrestling student-athlete participated in a contest while academically ineligible)*

- The Northview High School girls wrestling program has been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was declared ineligible for further competition until they met the minimum academic standards for eligibility.
- In accordance with Rule 3-9, the contest in which the ineligible student-athlete participated shall be rescored to remove any team points earned by the

ineligible student-athletes and the opposing school shall be notified of this violation.

- The administration of Northview High School is recognized for its appropriate management of this member school bylaw infraction. It is an essential responsibility of each member school to adhere to the association's bylaws and to promptly self-report any violations to the Commissioner, as stated in Rule 3.

Switzerland County - Boys Basketball - Rule 52-3c (*A student athlete participated in more than the allowable five (5) quarters in one session*)

- In accordance with Rule 3-9, Switzerland County High School shall forfeit the contest if victorious and the opposing school shall be notified of this violation.
- The administration of Switzerland County High School is commended for its handling of this member school bylaw violation. Part of an IHSAA member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

West Washington - Boys Wrestling - Rule 65-6b (*A student-athlete did not meet all provisions of the member school weight management program by participating in multiple matches without a physician's clearance form due to being under 7% body fat*)

- The West Washington High School wrestling program has been issued a warning. This warning is notice that a member school rule violation has occurred and shall not be repeated.
- Head Coach Dennis Tankersley is reprimanded for allowing this violation to be committed. The head coach holds the responsibility that each student-athlete meets all requirements of the member school wrestling weight management plan.
- While ineligible, the wrestling matches the student-athlete participated in shall be rescored to remove any individual and team points earned by the student-athlete and the team score shall be recalculated. The opposing member schools shall be notified of this violation.
- The administration of West Washington High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
