I. FOR ACTION

A. Approve the Minutes of the May 2, 2023 Executive Committee Meeting

Motion:

Motion moved by Jim Brown and motion seconded by Brian Strong. Approved 17-0.

B. Proposed Emergency Amendment to IHSAA By-Law 2-2 – Number of Schools in Classes

Commissioner Paul Neidig presented the rule proposal from the Indiana Interscholastic Athletic Administrators Association (IIAAA) that had been tabled at last month's Board of Directors meeting.

Motion:

Tim Grove made a motion to amend Rule 2-2 as it was presented so that sports with four classes would be divided with the largest 20% of schools would make up Class 4A, the next 25% would be Class 3A, the next 25% would be Class 2A, and the smallest 30% of schools would be Class A. Motion was seconded by Nathan Dean. Approved 17-1 with Chad Gilbert opposed.

Motion:

Motion to approve the new Rule 2-2 as amended below and effective in 2024-25 was made by Tim Grove and seconded by Nathan Dean. Approved 13-4-1 with Jeff Doyle, Tom Finicle, Chad Gilbert and Paul Voigt opposed and Stacy Adams abstaining.

Rule 2-2

The Directors have complete authority to establish and implement policies to determine the number of Classes and the number of Schools in each Class of competition in Team Sports. The following is the ~~eustomary~~ manner for classifying Schools:

- ~~a. If there are Two (2) Classes – 1A=50% of Schools; 2A=50% of Schools.~~
- ~~b. If there are Three (3) Classes – 1A=33% of Schools; 2A=33% of Schools; 3A=33% of Schools.~~
- ~~c. If there are Four (4) Classes – 1A=25% of Schools; 2A=25% of Schools; 3A=25% of Schools; 4A=25% of Schools.~~
- a. If there are Two (2) or Three (3) Classes, the division shall be ~~as follows~~ based on the number of schools participating in the sport:
 - (1.) If there are Two (2) Classes – 1A=50% of Schools; 2A=50% of Schools.
 - (2.) If there are Three (3) Classes – 1A=33% of Schools; 2A=33% of Schools; 3A=33% of Schools.
- b. If there are Four (4) Classes, the division shall be based on the number of full Member Schools.
 - (1.) If there are Four (4) Classes – 1A=30% of Schools; 2A=25% of Schools; 3A=25% of Schools; 4A=20% of Schools.
- c. If there is One (1) more School than equal division, that School may be placed in the smallest Class.
- d. If there are Two (2) more Schools than equal division, those Schools may be placed One each in the smaller Two (2) Classes.
- e. If there are Three (3) more Schools than equal division, those Schools may be placed One each in the smallest Three (3) Classes.
- f. When classifying all Team Sports other than football, no School may move down from a Class pre-determined by its enrollment number, even if the success factor causes a School to move up a Class forcing another School, without the correct enrollment number, to move down a Class. No School should be in lower enrollment classification than its pre-determined enrollment number.
- g. When classifying all Team Sports other than football, when Schools have equal enrollments at a customary break in classifications, all Schools with equal enrollments shall be placed in the higher enrollment classification.
- h. When classifying football, when Schools have equal enrollments at a customary break in classifications, the School with the largest freshman class shall be placed in the higher enrollment classification. If both Schools have an equal number of freshmen, then subsequent grades shall be used, i.e. sophomores then juniors then seniors to differentiate placement.

C. Proposed Emergency Amendment to IHSAA By-Law 2-5 – Reclassification of Schools in Team Sports due to previous Tournament Success

Commissioner Paul Neidig presented the rule proposal from Committee chairman Jeff Doyle that had been tabled at last month's Board of Directors meeting.

Motion:

Jeff Doyle motioned to amend his original proposal in section "d" and striking sections "g" and "h". His motion was seconded by Brian Strong. Approved 18-0.

Motion:

Tim Grove made a motion to merge Jeff Doyle's new proposal with a hybrid proposal presented by Commissioner Paul Neidig and seconded by Jim Brown. Approved 18-0.

Motion:

Motion to approve the new Rule 2-5 listed below was moved by Brian Strong and motion seconded by Tom Black. Approved 18-0.

Rule 2-5

In Team Sports, when Schools are subject to reclassification, a School's reclassification shall be dependent on the School's previous tournament series success; the Commissioner may, however, determine that a School's previous tournament series success should be applied more often, or less often.

- a. Schools shall earn the assigned point values for the final level of the tournament series they achieve as follows:
 - (1.) Sectional Championship - One (1) point
 - (2.) Regional Championship - Two (2) points
 - (3.) Semi State Championship - Three (3) points
 - (4.) State Championship - Four (4) points
- b. Upon the conclusion of a ~~Two (2) year reclassification and realignment cycle~~, **Two (2) consecutive tournament series in the same Class (previous and current year)**, Schools in Classes below the largest enrollment Class in a specific sport achieving Six (6) points or greater due to tournament series success shall move up to the next largest enrollment classification for the next Two (2) years. ~~reclassification and realignment cycle.~~
- c. After participation in a **the same** larger enrollment classification for Two (2) years, a School achieving a Two (2) year total tournament series success point value of ~~One (1)~~ **Two (2)** points or below in a specific sport shall be placed in the classification immediately below the Enrollment classification the School occupied during the previous two (2) year cycle unless the Enrollment of the School dictates the same or higher classification previously occupied in that sport.
- d. After participation in a **the same** larger Class enrollment classification for Two (2) years, a School achieving a tournament series success point value of ~~Two (2)~~, Three (3), Four (4) or Five (5) points in a specific sport shall remain in the same classification in that sport ~~for the next Two (2) years.~~
- e. After participation in a **the same** larger enrollment classification for Two (2) years, a School achieving a tournament series success point value of Six (6) points or greater in a specific sport shall move up to the next largest enrollment classification for the next Two (2) years. ~~reclassification and realignment cycle if their previous classification was below the largest enrollment Class in that sport.~~

The following amendment to the By-Laws was submitted by Stacey Brewer, Principal, Yorktown High School.

Rule 2-5

In Team Sports, when Schools are subject to reclassification, a School's reclassification shall be dependent on the School's previous tournament series success; the Commissioner may, however, determine that a School's previous tournament series success should be applied more often, or less often.

- c. After participation in a larger enrollment classification for Two (2) years, a School achieving a Two (2) year total tournament series success point value of ~~One (1) point~~ **Three (3) points** or below in a specific sport shall be placed in the classification immediately below the Enrollment classification of the School occupied during the previous Two (2) year cycle unless the Enrollment of the School dictates the same or higher classification previously occupied in that sport.
- d. After participation in a larger enrollment classification for Two (2) years, a School achieving a tournament series success point value of ~~Two (2), Three (3),~~ Four (4) or Five (5) points in a specific sport shall remain in the same classification in that sport for the next Two (2) years.
- f. **Following participation in a larger enrollment classification advancement of Two (2) or more class levels (a 2A school playing in a 4A tournament series), a School achieving a Two (2) year total tournament series success point value of Zero (0) in a specific sport shall be placed in the School's enrollment size classification in that sport.**

I. 2023-24 Girls Golf Tournament Series

Assistant Commissioner Chris Kaufman reported on the general format, sites and other preliminary plans for the 2023-24 Girls Golf Tournament Series.

Tom Black asked if the state finals could accommodate the advancement of three individuals instead of just two individuals from each regional. Kaufman commented that having completed one full year under the new format that data showed the tournament did work well in advancing the top three teams and top two individuals from each regional, however, a study with the addition of one individual for a total of three would be good to study also. Kaufman indicated that the IHSAA, the Indiana High School Golf Coaches Association and Prairie View Golf Club, the host of the state finals, are receptive to and could accommodate an additional advancing individual player from each regional to the state finals for a total of 108 total golfers.

With that, Black requested that for 2023-24 Girls and Boys Golf State Tournaments, the top three teams and top three individuals not on an advancing team, will advance to the state finals.

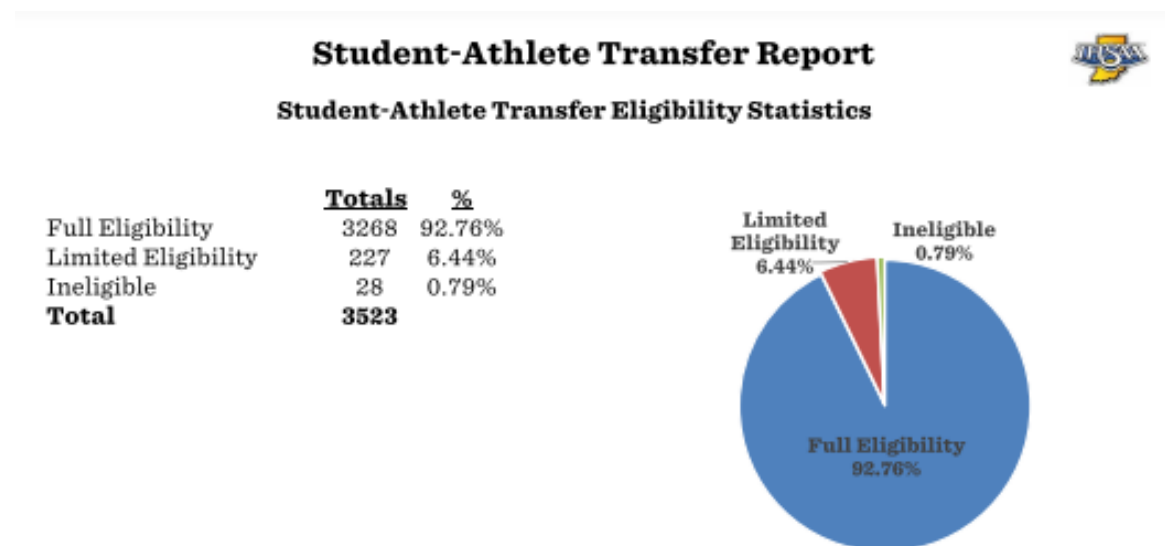

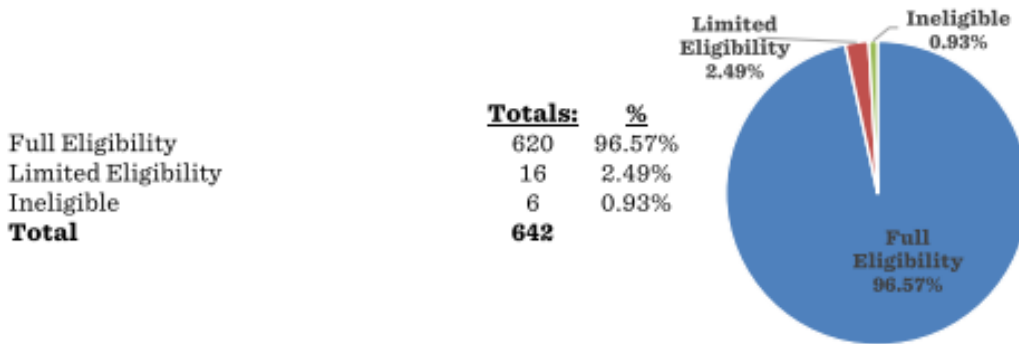

- Part of an IHSA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Roncalli – Football – Rule 9-13 (*Members of the coaching staff conducted a zoom meeting on a Sunday with student-athletes*)

- The Roncalli High School football program is issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- A meeting shall be scheduled with the entire football coaching staff of Roncalli High School to review IHSAA member-school by-law 9. Once this meeting is complete, the date of the meeting, meeting agenda, and attendance shall be sent to Assistant Commissioner Faulkens.
- The IHSAA accepts the suspension levied by the school for the three coaches involved. Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation for all involved coaches which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by student-athletes, coaches, or affiliates of the football program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- Part of an IHSAA member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Shelbyville– Baseball – Rule 19-3 (*A student-athlete participated in multiple interscholastic contests without an approved transfer on file*)

- The Shelbyville baseball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- The student-athlete was declared ineligible until a completed transfer report was submitted and ruled upon.
- The interscholastic contests in which the student-athlete participated shall be forfeited. The opposing schools shall be made aware of this violation.
- Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

South Knox – Basketball – Rule 15-2.5 – Second Violation (*A Limited contact session was held on March 13, 2023, outside the limited contact period*)

- Probation for the South Knox High School basketball program has been extended until August 2024. This probation is a severe notice of a rule violation occurring and shall not be repeated.
- Head Coach David Burkett and Assistant Coach Holscher are placed on probation for permitting this violation to occur. It is the responsibility of the head coach to ensure all student athletes follow member School rules. Further infractions of IHSAA Member School By-Laws may result in the revocation of Coach Burkett's and Coach Holscher's coaching accreditation which is outlined in Rule 7.
- Assistant Coach Holscher is suspended for the first 5 varsity contests and all subsequent contests at any level until the five (5) game suspension is complete. Coach Holscher is not to scout opponents or be in attendance at a contest during this suspension.
- The basketball program's maximum number of limited contact sessions is reduced by six (6) from 16 to 10 during the fall limited contact period.

- Any subsequent Member School By-Law violations committed by the boys' basketball program shall disqualify South Knox High School from participation in the 2023-24 IHSAA boys' basketball tournament series.

South Knox – Softball – Rule 19-3 (*A student-athlete participated in multiple interscholastic contests without an approved transfer on file*)

- The South Knox softball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- The student-athlete was declared ineligible until a completed transfer report was submitted and ruled upon.
- The interscholastic contests in which the student-athlete participated shall be forfeited. The opposing schools shall be made aware of this violation.
- Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Taylor - Boys Track & Field – Rule 18-1 (*A student-athlete participated in multiple interscholastic contests while academically ineligible*)

- The Taylor High School track & field program is issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation shall be declared ineligible for further competition until they meet the minimum academic standards for eligibility.
- In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated shall be rescored to remove any team points earned by the ineligible student-athlete and the opposing school(s) shall be notified of this violation.
- Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Terre Haute South Vigo – Boys Golf – Rule 19-3 (*A student-athlete participated in multiple interscholastic matches without an approved transfer on file*)

- The Terre Haute South golf program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- The student-athlete was declared ineligible until a completed transfer report was submitted and ruled upon.
- The interscholastic contests in which the student-athlete participated shall be forfeited. The opposing schools shall be made aware of this violation.
- Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Wawasee- Baseball – Rule 18-1 (*A student-athlete participated in multiple interscholastic contests while academically ineligible*)

- The Wawasee High School baseball program is issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.

- The student-athlete involved in this violation was declared ineligible for further competition until they meet the minimum academic standards for eligibility.
- In accordance with Rule 3-9, if Wawasee High School was victorious, the interscholastic contests in which the ineligible student-athlete participated in shall be forfeited. The opposing school shall be made aware of this violation.
- Part of an IHSA member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
