C. By-Law 19-3.2

Commissioner Paul Neidig and General Counsel Katie Williams-Briles submitted a clarification of Rule 19-3.2 (First Time Transfer Between Member Schools) as listed below.

The online version of the Member School By-Laws will be updated to reflect this.

19-3.2 First Time Transfer Between Member Schools

- a. Students who transfer ~~between Member Schools~~ for the first time ~~ever~~ during the first Six (6) semesters after their initial high school enrollment will have full eligibility, provided:
 - (1.) The transfer is between Member Schools;
 - (2.) The transfer occurs on or before the Start of Practice Date of the sports season in which the transfer occurs; and
 - (3.) The transfer is not the result of undue influence (rules 20-1 and 20-2, past link).
- b. Students who transfer during the first six (6) semesters, having had the opportunity to participate in three (3) seasons of eligibility of a sport, will be subject to a Thirty (30) day non-competition period or half (1/2) the Maximum Number of Contests, whichever is less, in each sport in which they participated during or after their third year of eligibility, during the Three-hundred Sixty-five (365) days preceding the transfer.

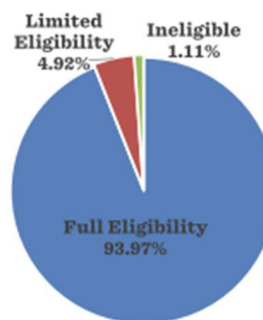
D. Explanation of Policy Manual

Assistant Commissioner Brian Lewis reported on transfers that have been ruled on for the period of June 1, 2025-August 19, 2025.

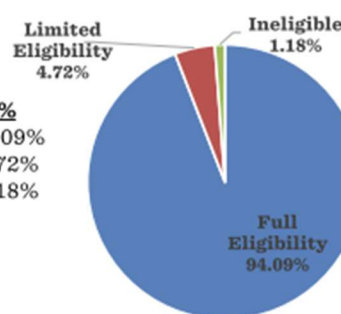

J. Officials

Assistant Commissioner Brian Lewis provided the numbers of licensed officials by sport for 2025-26. There are 5,311 licensed individuals which is fairly typical for this time of year though the numbers in football, volleyball and soccer were each down from previous years. Girls Lacrosse has also been added for the first time.

Lewis also shared a list provided by RefReps that shows 102 member schools using Officiating 101 as part of their curriculum this semester. This course offering is helping to license younger individuals in the officiating ranks.

N. Distinguished Media Service Award

Sports Information Director Jason Wille reported on this year's Distinguished Media Service Awards. One individual in each of the three districts will be selected for this honor and recognized later this school year for their contributions to high school athletics.

O. Penalties Assessed

Jeffersonville - Boys Basketball - Rule 15-2.4 - Student-athletes were in the gym before the school day, outside the limited contact period

- The Jeffersonville High School boys' basketball program has been issued a warning for allowing this member school by-law violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.
- Head Coach Sherron Wilkerson is placed on notice for permitting this violation to occur. It is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.
- The fall boys' basketball limited contact sessions are reduced by 1 to a maximum of 15 sessions.
- Further digressions as they relate to Member school by-laws by student-athletes, coaches, or affiliates of the boys' basketball program and may include further sanctions, including but not limited to, suspensions of coaches and/or student-athletes and/or probation for the program.
- Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Jeffersonville - Football - Rule 20-2 - The head coach attempted to recruit a student-athlete from another member school

- The Jeffersonville High School football program has been issued a warning. This warning is notice of a rule violation occurring and shall not be repeated.
- The IHSAA agrees and supports the decision of the Jeffersonville Administration to suspend Coach Joe Washington for the first regular season

contest for the 2025-26 season. Please note, it is the responsibility of the head coach to ensure all assistant coaches and student-athletes follow member School rules.

- Additionally, Coach Washington is placed on probation until August 1st, 2026, for allowing this violation to occur. Further infractions of IHSAA Member School bylaws will result in the revocation of Coach Washington's coaching accreditation which is outlined in Rule 7.
- In accordance with Rule 9-16b (3) all contracted opponents may withdraw from an existing contest contract if their opponent was in violation of Member School bylaw, Rule 20 Undue Influence. All contracted Football opponents for the 2025-26 school year shall be notified of this Rule 20 violation and given the option to withdraw from an existing contract. Please include Assistant Commissioner Robert Faulkens on all communication with contracted opponents.
- The administration of Jeffersonville High School is commended for its handling of this member school bylaw violation. Part of an IHSAA member school's duty is to uphold the member school bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Lanesville - Boys Soccer - Rule 15-2.5f - The head coach hosted a soccer camp during moratorium week

South Bend Adams -Baseball - Rule 19-3 - A student-athlete participated in multiple contests without a completed transfer on file

- The South Bend Adams High School baseball program has been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- Further digressions as they relate to member school bylaws by student-athletes, coaches, or affiliates of the baseball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- In accordance with Rule 3-9, the contests in which the ineligible student-athlete participated in shall be forfeited and the opposing schools shall be notified of this violation.
- The administration of South Bend Adams High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Southport - Girls Volleyball & Girls Basketball - A student-athlete participated in open gym activities before step one of the transfer report was complete

- The Southport High School girls basketball and volleyball programs have been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- Further digressions as they relate to member school bylaws by student-athletes, coaches, or affiliates of the basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Southport High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Westfield - Girls Soccer - Rule 15-1.1 - A student-athlete participated in a non-school soccer event during the contest season

- The Westfield girls soccer program has been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- The student-athlete involved in this violation was not permitted to participate in the next two interscholastic contests upon return.
- Further digressions as they relate to Member school bylaws by student-athletes, coaches, or affiliates of the soccer program, shall include further sanctions, including but not limited to, further suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Westfield High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Whiting - Football - Rule 15-2.7 - The football squad was dressed in shoulder pads for 19 practices during the summer which surpasses the Twelve (12) day limit.

- The Whiting High School Football program and Head Football Coach Thomas Knight have been formally issued a written warning. This notice serves as official documentation that an IHSA bylaw Violation has occurred and must not be repeated.

- Rule 55-4 is established to ensure the health and safety of student athletes involved in Football, and strict compliance with these provisions is required.
- Additional violations of member school bylaws by student-athletes, coaches, or program affiliates may result in further sanctions, such as suspension of coaches or student-athletes, or probation for the program.
- The administration of Whiting High School is recognized for its appropriate management of this member school bylaw infraction.
