## II. REPORTS

# A. Certify the 2025 Board of Directors Election Results

In most years, the results of the annual Board of Directors election are part of this meeting's agenda. But because today's meeting falls on the final day of this year's election, Commissioner Paul Neidig will inform all candidates of the results as soon as they are known this week. Certification of the results will be part of next month's meeting agenda set for Thursday, January 15, 2026.

# B. Reflections on the Small School Focus Group Meeting

Commissioner Paul Neidig recapped the meeting he and the assistant commissioners hosted on Wednesday, Nov. 19 at the IHSAA.

The meeting gave voice to administrators representing many 1A and 2A schools to share their concerns and viewpoints with regard to high school athleitics. Topics covered were summer participation, review of school classification criteria, transition between athletic season (notably the five-practice rule), and advocacy for small school athletic directors.

Neidig anticipates another meeting to be scheduled again in the spring.

# C. Appoint Screening Committee for C. Eugene Cato Memorial Scholarship Applications

Foundation President Chris Kaufman asked for two volunteers from each legislative district to serve on this year's screening committee. Volunteers will review and select the recipients from districts other than their own. Those serving are:

## D. Girls Flag Football


Commissioner Paul Neidig and Assistant Commissioners Robert Faulkens and Chris Kaufman were invited to meet with Indianapolis Colts owner Kalen Jackson and Colts Chief Operating Officer Pete Ward to review the sport of Girls Flag Football earlier this month. Jackson is part of the NFL's Steering Committee which is invested in creating opportunities for female athletes to play the sport in all 50 states.

Seventy-eight (78) teams participated in this fall's state tournament which was administered by the Girls Flag Football Coaches Association in conjunction with the Indianapolis Colts. At this point, 108 teams have committed for next fall's tournament. All are hopeful that more schools from urban areas will field teams.

The girls coaches association will still administer next year's tournament but Neidig says the IHSAA will become more directly involved with Faulkens administering the sport and Assistant Commissioner Brian Lewis will oversee the flag football officials.

## E. Transfers

Assistant Commissioner Brian Lewis reported on the number of transfers (chart listed next page) that have been ruled upon for the period of June 1, 2025 and December 2, 2025 (left) and, for comparison, the numbers from the same period a year ago (right).



# F. Officials Update

Assistant Commissioner Brian Lewis shared the updated 10-year look at licensed officials by sport. Among fall sports, the numbers of soccer officials and volleyball officials ended down from a year ago, while football remained steady.

Lewis also shared the latest survey data from the Officials' Host School Contest Experience.

# G. Sportsmanship

Assistant Commissioner Jane Schott shared that 1,127 Exemplary Sportsmanship Reports have been received so far this year with 964 of those coming from licensed officials.

She has received 428 reports of ejections during fall sports. 52% of those have occurred in boys soccer, 30% in football, and 10% in girls soccer. The remaining fall sports combined for 8%.

The All-Sportsmanship teams for fall sports will be announced in the coming days.

# H. Technology

Director of Technology Luke Morehead demonstrated an improved process for tracking and onboarding prospective officials in the myIHSAA portal. Director Morehead also shared design updates planned for myIHSAA and IHSAA.org as well as a recently-implemented statewide online search tool for regular season contest schedules.

Commissioner Paul Neidig added that we're seeing a lot of growth with our Instragram and Tik Tok social media accounts. He warned of the numerous fake accounts on social media that continue to disguise themselves using the IHSAA logo, similar handle names to our own, and pushing spam links. We continue to report these accounts to platform administrators.

Neidig also expressed concern with the NFHS Network airing advertisements for watching IHSAA games on their network and using the IHSAA logo without permission.

He also reported that MaxPreps, our statistics and bracketing partners, have been purchased by PlayOn which is affiliated with the NFHS.

# I. Legal

Attorney Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association and recent Case Review Panel rulings.

Williams-Briles also updated the group on NIL legislation in other states and how its affecting state associations.

### J. Penalties Assessed

21st Century Academy - Boys Basketball - Rule 19-3.3 b (*A student-athlete participated in a varsity contest while athletically ineligible*)

- The 21st Century Academy High School boys basketball program has been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- Under Rule 3-9, any contests involving the ineligible student-athlete must be forfeited, and opponents shall be notified. The athlete remains ineligible for the next contest after completing the 30-day non-compete period.
- Any additional violations of member school bylaws by student-athletes, coaches, or affiliates of the boys basketball program could result in further penalties. These may include suspension of coaches or student-athletes, as well as probation for the entire program.
- The administration of 21st Century Academy High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Beech Grove High School – Girls Volleyball– Rule 19-3 (A student athlete participated in multiple JV matches without a completed transfer form on file)

- The Beech Grove High School girls volleyball program has received an official warning. This notice documents that a member school bylaw violation has occurred, is recorded as such, and must not happen again.
- In accordance with Rule 3-9, the contests in which the ineligible student-athlete participated in shall be forfeited and the opposing schools shall be notified of this violation.
- Further digressions as they relate to member school bylaws by student-athletes, coaches, or affiliates of the girls volleyball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Beech Grove High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Fairfield High School - Boys Wrestling – Rule 19-3 (A student athlete participated in a JV contest without a completed transfer form on file)

- The Fairfield High School boys wrestling program has been issued a warning.
   This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- Further digressions related to member school bylaws by student-athletes, coaches, or affiliates of the boys wrestling program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated shall be forfeited and any team points earned by the ineligible student-athlete shall be removed from the final score and the opposing school shall be notified of this violation.
- The administration of Fairfield High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Hagerstown High School - Boys Basketball - Controlled Scrimmage (Members of the boys basketball staff attended a scrimmage between two other member schools)

- The Hagerstown High School boys basketball program has been issued a warning. This warning is official notice that a member school bylaw violation has occurred, is a matter of record, and shall not be repeated.
- Further digressions related to member school bylaws by student athletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Hagerstown High School is commended for its handling of this member school bylaw violation. Part of an IHSAA member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Muncie Burris High School - Girls Basketball - Rule 19-3.3b (A student-athlete participated in four varsity games while athletically ineligible)

- The Muncie Burris High School girls basketball program has been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- In accordance with Rule 3-9, the contests in which the ineligible studentathlete participated in shall be forfeited and the opposing schools shall be notified of this violation.
- Any additional violations of member school bylaws by student-athletes, coaches, or affiliates of the girls basketball program could result in further penalties. These may include suspension of coaches or student-athletes, as well as probation for the entire program.
- The administration of Muncie Burris High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Munster-Boys Swimming & Diving - Rule 3-10 (A student-athlete participated in two meets without a complete physical form on file)

- The Munster High School boys' swimming & diving program has been issued a warning. This warning is official notice that a member school bylaw violation has occurred, is a matter of record, and shall not be repeated.
- In accordance with Rule 3-9, the contest in which the ineligible student-athlete participated shall be rescored to remove any team points earned by the ineligible student-athletes and the opposing school shall be notified of this violation.
- Further digressions related to member school bylaws by student-athletes, coaches, or affiliates of the boys' swimming & diving program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Munster High School is commended for its handling of this member school bylaw violation. Part of an IHSAA member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Portage High School - Girls Wrestling - Rule 19-3 (A student athlete participated in a contest without a completed transfer form on file)

- The Portage High School girls wrestling program has been issued a warning. This warning is official notice that a member school bylaw violation act has occurred, is a matter of record, and shall not be repeated.
- Further digressions related to member school bylaws by student-athletes, coaches, or affiliates of the girls wrestling program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- In accordance with Rule 3-9, the contest(s) in which the ineligible studentathlete participated shall be forfeited and any team points earned by the ineligible student-athlete shall be removed and the opposing school shall be notified of this violation.

Roncalli High School - Girls Lacrosse - Rule 15-2.4 (*The girls lacrosse team scrimmaged against the boys lacrosse team outside the limited contact period*)

- The Roncalli High School girls lacrosse program has been issued a warning for allowing this member school bylaw violation to occur. This warning is notice of a rule violation occurring and shall not be repeated.

- The administration of Warren Central High School is commended for its handling of this member school bylaw violation. Part of a member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Yorktown - Boys Basketball - Rule 50-1.1 (Three student athletes did not have the required five (5) practices in when moving directly from one sport to the next before competing in the scrimmage)

- The Yorktown boys basketball program has been issued a warning. This warning is official notice that a member school bylaw violation has occurred, is a matter of record, and shall not be repeated.
- Further digressions related to member school bylaws by student-athletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Yorktown High School is commended for its handling of this member school bylaw violation. Part of an IHSAA member school's duty is to uphold the bylaws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
