

## A. Transfers


Assistant Commissioner Brian Lewis reported on transfers that have been ruled on for the period of June 1, 2023-December 5, 2023.

## B. Contest Officials

Assistant Commissioner Brian Lewis provided updated data on the number of licensed officials by sport and the numbers of renewals by sport for the current school year.

Lewis also shared results and feedback he's received from a host school survey that licensed officials completed for fall sports. The information has been valuable to share with athletic directors, particularly those that are new to their positions.

## C. Ejection Report

Assistant Commissioner Janie Ulmer shared the list of ejections since November 1. During that time, there have been 24 ejections (13 student-athletes, 5 coaches, 5 spectators, 1 administrator) (13 in basketball, 9 in wrestling, 2 in football).

# D. Sportsmanship Task Force Report

Assistant Commissioner Janie Ulmer and Brian Lewis will be sending out a survey to administrators in the next couple of weeks soliciting feedback on sportsmanship ideas and how to address some of the issues. A sportsmanship task force will then be formed to study and analyze that information and offer recommendations on the approach and a vision for the IHSAA sportsmanship program.

Ulmer also presented the list of exemplary sportsmanship reports received since November 1. Fortunately, it was a much longer list than the list of ejections.

# E. Eleven States Meeting

Commissioner Paul Neidig reported on his visit with leaders from other Midwestern state associations on December 4-5, 2023, in Chicago.

Some of the many topics covered included:

- The IHSAA Student Advisory Committee and its Student Leadership Conference were of interest to other states in the process of developing their own.
- Various communications strategies and long-term financial projections.
- Neidig spoke to the IHSAA's new Champion Educator Award which began last
  winter. The award celebrates educators, including educators in the traditional
  classroom and the noble profession of teaching. One teacher from each state
  finalist team is recognized for their ability to connect with their students in a
  way that leads students to become the best versions of themselves, both inside
  the classroom and out.

# F. Technology

Director of Technology Luke Morehead provided an update regarding recent improvements to the myIHSAA portal, specifically in the areas of digital ticketing, financial reporting, and the Resource Library. Director Morehead noted that the development team is currently implementing suggestions received during the fall member technology survey.

#### G. Foundation

IHSAA Foundation Director Trip Lukemeyer and Foundation President Chris Kaufman reported on the Foundation's status. The Foundation is committed to providing a positive experience and support for member-schools, student-athletes, officials, and promoting the mission of education-based athletics.

They are conducting a year-end campaign to engage donors and encourage contributions, utilizing social media, email, and letters, while focusing on four pillars identified as needed areas of support:

- Scholarships
- Student Advisory Committee (SAC) Grant
- Leadership Development Resources and Grant
- Officiating 101 Resources and Grants

## H. Service to Membership

Associate Commissioner Ed Gilliland, who in his role promotes, advocates, and teaches the philosophy of the IHSAA and education-based athletics, reported on his travels around the state since the beginning of the school year.

He detailed his meetings with school administrators at more than 40 schools, specifically new athletic directors, by meeting them in person or answering questions via phone call or email. He has been a guest at conference meetings and also spoken at an officiating class offered at Chesterton High School.

Gilliland attended the various fall principals' meetings, met with leadership from the Indiana Interscholastic Athletic Administrators Association, and assisted at several state finals events in support.

# I. Sports Medicine Advisory Committee (SMAC)

Assistant Commissioner Robert Faulkens reported that the SMAC is requesting feedback from schools on recent changes with respect to Back-to-School and Return-to-Play guidelines.

Faulkens reported the American Academy of Pediatrics has updates and that a new physical evaluation form (PPE) will be made available in January for the 2024-25 school year.

He also relayed that SMAC has expressed concern of the lack of athletic trainers and primary care physicians in certain parts of the state.

## J. General Counsel Report

Attorney Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association and recent Case Review Panel rulings.

#### K. Penalties Assessed

Boone Grove High School – Boys Basketball – Rule 3-10b (Multiple student athletes participated in an officials practice with having a completed physical form

- The Boone Grove High School boys' basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Head Coach Dean Hill is reprimanded for committing this violation. Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by studentathletes, coaches, or affiliates of the boys' basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Boone Grove High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Bremen High School- Girls Basketball - Rule 9-13 (Two middle school basketball coaches and a volleyball coach opened the Bremen school facility and gave access to four student athletes on a Sunday)

- The Bremen High School girls' basketball program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by studentathletes, coaches, or affiliates of the girls' basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.

- The Brown County High School boys' basketball program has been issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- The Assistant Coach is reprimanded for committing this violation. Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by studentathletes, coaches, or affiliates of the boys basketball program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Brown County High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Carmel High School – Boys Basketball – Rule 52-3 c (A student athlete participated in more than the allowable five (5) quarters in a single session)

- The Carmel High School boys basketball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- All six (6) quarters shall count against the maximum number of quarters allowed for the student athlete involved in this violation.
- In accordance with Rule 3-9, Carmel High School shall forfeit the contest if victorious and the opposing school shall be notified of this violation.
- The administration of Carmel High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Carroll (FW) High School – Softball – Rule 15-2.2(c) (An assistant coach coached members of the softball team during the school year, out of season)

- The Carroll (FW) High School softball program has been issued a warning. This warning is official notice that member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- A meeting shall be scheduled with the entire softball coaching staff of Carroll (FW) High School to review IHSAA member-school by-law 15. Once this meeting is complete, the date of the meeting, meeting agenda, and attendance shall be sent to Assistant Commissioner Rosati.
- Assistant Coach Kaylie Hammel is reprimanded and not permitted to coach the
  first regular season contest for 2023-24 season for allowing this violation to
  occur. Further infractions of IHSAA member school By-Laws may result in the
  revocation of Kaylie Hammel's coaching accreditation which is outlined in
  Rule 7.
- Further digressions as they relate to Member school by-laws by studentathletes, coaches, or affiliates of the softball program and may include further sanctions, including but not limited to, further suspensions of coaches and/or student-athletes and/or probation for the program.
- The administration of Carroll (FW) High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the member school by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

East Noble High School – Wrestling – Rule 63-6 (A wrestler participated in a JV match and did not meet all provisions of the member school weight management program)

- The East Noble High School wrestling program has been issued a warning. This
  warning is notice that a member school rule violation has occurred and shall
  not be repeated.
- Head Coach Sam Riesen is reprimanded for allowing this violation to be committed. The head coach holds the responsibility that each student-athlete meets all requirements of the member school wrestling weight management plan.
- While ineligible, the wrestling match the student-athlete participated in shall be rescored to remove any individual and team points earned by the student-athlete and the team score shall be recalculated. The opposing member schools shall be notified of this violation.

• The administration of East Noble High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Harrison (West Lafayette) High School – Wrestling – Rule 9-18b (A student manager filmed a wrestling match for a specific weight class)

- The Harrison (West Lafayette) High School wrestling program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Further digressions as they relate to member school by-laws by studentathletes, coaches, or affiliates of the wrestling program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- The administration of Harrison (West Lafayette) High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

South Adams High School – Wrestling – Rule 63-6 (A wrestler participated in a JV match and did not meet all provisions of the member school weight management program)

- The South Adams High School wrestling program has been issued a warning. This warning is notice that a member school rule violation has occurred and shall not be repeated.
- Head Coach Robert Loshe is reprimanded for allowing this violation to be committed. The head coach holds the responsibility that each student-athlete meets all requirements of the member school wrestling weight management plan.
- While ineligible, the wrestling match the student-athlete participated in shall be rescored to remove any individual and team points earned by the student-athlete and the team score shall be recalculated. The opposing member schools shall be notified of this violation.
- The administration of South Adams High School is commended for its handling of this member school by-law violation. Part of a member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Union City High School – Boys Basketball – Rule 52-3 c (A student athlete participated in more than the allowable five (5) quarters in a single session)

- The Union City High School boys basketball program has been issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- All six (6) quarters shall count against the maximum number of quarters allowed for the student athlete involved in this violation.
- In accordance with Rule 3-9, Union City High School shall forfeit the contest if victorious and the opposing school shall be notified of this violation.
- The administration of Union City High School is commended for its handling of this member school By-Law violation. Part of a member school's duty is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Valparaiso High School – Wrestling – Rule 3-10b (A student athlete participated in an official practice and multiple matches without a completed physical form)

- The Valparaiso High School wrestling program has been issued a warning. This warning is official notice that a member school by-law violation has occurred, is a matter of record, and shall not be repeated.
- Head Coach Jake Plesac is reprimanded for committing this violation. Further infractions of IHSAA member school by-laws may result in the revocation of coaching accreditation which is outlined in Rule 7.
- Further digressions as they relate to member school by-laws by studentathletes, coaches, or affiliates of the wrestling program and may include further sanctions, including but not limited to, suspension of coaches and/or student-athletes and/or probation for the program.
- While ineligible, the wrestling matches the student-athlete participated in shall be rescored to remove any individual and team points earned by the student-athlete and the team score shall be recalculated. The opposing member schools shall be notified of this violation.
- The administration of Valparaiso High School is commended for its handling of this member school by-law violation. Part of an IHSAA member school's duty is to uphold the by-laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).
