# Administrators elected to IHSAA Board of Directors

Three high school administrators have been re-elected to the IHSAA Board of Directors and three more will begin their first term following annual voting conducted within member schools this month.

Through electronic balloting, each member school principal had the opportunity to vote for the candidates running for seats in their respective district during the election held Dec. 1-10, 2025.






Those re-elected to serve a new three-year term include:

Each individual will begin their three-year terms on the IHSAA Board of Directors on July 1, 2026.

The members of the Board of Directors, who also serve on the Executive Committee, meet annually on Monday of Week 44 of the IHSAA calendar (May 4, 2026) to consider and vote on any changes to the Member School By-Laws—which provide the governing framework for the Association—that are proposed by any member schools or the Commissioner. The Board of Directors (and by extension, the Executive Committee) consists of 19 elected officials who represent member schools in all three districts of the state.

#### About the 2025-26 IHSAA Board of Directors

The IHSAA is governed by its legislative body, the Board of Directors. Composed of 19 individuals elected by member school principals from three legislative districts, they serve staggered three-year terms. Twelve board seats are filled by any qualified individual (open seats), and seven board seats are filled by two qualified female representatives, two qualified minority representatives, two qualified urban school representatives and one qualified private school representative. The Board of Directors meets annually with the responsibility of establishing the Association's By-Laws and regulations.

## About the Indiana High School Athletic Association, Inc. (IHSAA)

The IHSAA is a voluntary, not-for-profit organization that is self-supporting without the use of tax monies. Since its founding in 1903, the Association's mission has been to provide wholesome, educational athletics for the secondary schools of Indiana. Its 412-member high schools - public, institutional, parochial, and private – pay no annual membership fee or incur entry fees to play in the Association's tournaments. A state tournament series is conducted annually in 24 sports, 11 for girls, 11 for boys and two co-eds (Unified Flag Football, Unified Track and Field). A 19-person board of directors, elected by member school principals, governs the organization.
